3.2 Declaration of Interests: No interests declared

3.3 Minutes of Previous Meetings and Matters arising

The February Minutes were approved and signed by the Chairman as a true and correct record and unanimously approved by all Councillors.

Emergency Plan – A reminder that an exploratory meeting will take place at the Prince of Wales, Holcombe Rogus on **Thursday April 24**th **2025 at 8.00pm**. This meeting is a public meeting and everyone is welcome. This will take place after we have held our Annual Parish meeting which will be held at the King George V Memorial Hall which commences at **6.45pm**.

3.4 Environment

3.4.1 PROW:

Cllr Frances Freeman met with John Boyd (Rights of Way Officer) and it was confirmed by DCC that the improvements to footpath number 3 should be carried out. Cllr Frances Freeman is in discussion with the landowner.

3.4.2 <u>Canal Report</u>

Trimming of the Canal's banks and hedges and towpath restoration is under way with the Tiverton end now complete.

3.4.3 Whipcott Quarry Limekiln – It was noted that this would need to be cleared of ivy to reveal artefact, however there are concerns over removing the ivy as the roots cling to walls and can dislodge or damage masonry. Update on this will follow due to contact being on holiday. It was noted that the fallen tree over the canal at Wharf House has not yet been tidied up.

3.5 <u>Highways</u>

3.5.1 Gordon Czapiewski confirmed that a majority of the potholes have now been repaired. Albeit randomly picked for repair.

- 3.9.2 Cllr Sally Barker was approached by a resident with concerns over the stream at Whitebrook.
